



**PLAYER WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION FOR ANYTHING UNDER  
SANGER WARRIORS FASTPITCH SOFTBALL  
PERIOD COVERED 6/1/2020 TO INDEFINITE**

I, the undersigned player or parent/guardian (if player is minor), acknowledge, agree and understand that:

- 1.) Voluntarily and of my own free will, I elect to participate in the Sanger Warriors Fastpitch open team workouts/tryouts/practices/clinics/tournaments/guest playing/any other gathering under Sanger Warriors not mentioned, now, during, and after the Covid-19 pandemic.
- 2.) I understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players, including, but not limited to those hazards: associated with weather conditions, playing conditions, field design, field maintenance, field condition, equipment, illnesses, viruses, or other participants.
- 3.) I understand that softball is dangerous to me and to other players and may result in serious injury or death.
- 4.) I understand that the very nature of the game of softball is hazardous and risky, including, but not limited to, the acts of swinging, hitting, throwing, running, falling, slipping, fielding, catching of the ball, running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.
- 5.) I understand that any event not sanctioned by Sanger Warriors Fastpitch Softball may not be covered under the organization's insurance policy and I am fully responsible for any injuries occurred during those events.

Furthermore, I the undersigned player, agree that in consideration for the right to workout/tryout/practice/clinics/tournaments/guest playing with or as a member of the Sanger Warriors Fastpitch Softball and in consideration for permission to play on the fields arranged for by the team, I agree as follows:

- 1.) I acknowledge that I have a duty to inspect the conditions of the field and areas surrounding prior to each time I participate and throughout my participation. If I begin any part of participation thereof, I waive any claim for any injury arising from a defective condition of the field or surrounding area.
- 2.) I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while working out, trying out, participating, practicing or playing with or as a member of the team so designated, (b) while serving in a non-playing capacity with or as a team member during tournaments, while guest playing, workouts, tryouts, participation, practice or play by other teams or by other players on Sanger Warriors Fastpitch Softball, (c) while on or upon the premises of any and all of the fields arranged for by Sanger Warriors Fastpitch Softball for working out/trying out, participating, practice or play, and (d) for all risks of injury associated with any latent or patent defects of the field or the improvements surrounding the field.
- 3.) I release, discharge, and agree not to sue Sanger Warriors Fastpitch Softball, the city, the field owner, the league, the association, any officers, agents, servants, associations, employees, or any person or entity connected with the team, or field, for any claim, damages, costs or cause including but not limited to the negligence, omission, breach of contract or wrongful conduct of these parties. I hereby release from liability all mentioned parties and take full financial, physical, and emotional responsibility for any injury or injuries resulting in tournaments, guest playing, participating, working out, trying out, practicing, or playing for Sanger Warriors Fastpitch Softball and the parties mentioned.
